

Editor's Report on Volume 86, 2015

Production

The 6 regular issues of volume 85, 2015 (2014, 2013, 2012, 2011, 2010) contained 763 (690, 601, 675, 765, 771) printed pages with 110 (105, 100, 105, 120, 126) original articles. Of the 112 articles, 24 were register studies, 6 randomized clinical trials, 3 case reports/technical notes. Furthermore we published 8 editorials and 5 letters to the editor. We published 4 supplements (altogether 138 pages).

Submission and publication of manuscripts (Table 1)

940 manuscripts were submitted (972 in 2014, 989 in 2013, 786 in 2012, 741 in 2011, 685 in 2010).

60 % were clinical, 20 % case reports, 10% experimental, 6 % reviews and 4 % others, the same distribution since several years.

One fifth (204/940) of the manuscripts were submitted from NOF members.

Of the 110 published articles Sweden contributed 21, Denmark 18, the Netherlands 14, Finland 11, Norway 11, UK 11, Germany 4, Australia 4.

Country distribution of submitted and published manuscripts is similar since several years except for an ongoing increase in manuscripts submitted from China (this year 94, very few accepted).

Please note that direct comparisons of the number of submitted manuscripts and published articles per country and year is not meaningful. There is an overlap between years; many of the ms submitted one year are published the next year.

Handling times and acceptance rate

70 % of ms (except those immediately rejected by in-house evaluation, < 1 wk) have a first decision letter within 3 weeks, 85 % within 6 weeks.

The mean time from submittance to acceptance was < 3 months for one third of ms, and 4-6 months for half of the ms. Acceptance times partly depend on the number of revisions necessary and the time taken by authors to do these revisions. Almost all ms undergo 1 or more revisions before acceptance. Handling times have been about the same since 5 years.

The mean time from acceptance to paper publication was 7 months 2015. This half year from acceptance

to paper print is of less interest; in 2009 we started online preprint publication of proofs which are free on PubMed (Epub ahead of print) 2-3 weeks after the authors has accepted them.

The acceptance rate in 2015 was 12 %, the same as in 2012-13 but a decrease from the around 20 % we have had since 2004.

Almost all case reports were rejected (without external review). Of the other ms half were rejected in-house (that is without external review) whereas the other half were sent for review, most often by 2 external experts. Half of these were rejected after external review, the remaining half (just over 100) were accepted.

Our high rejection rate is a combination of our increasing quality requirements and the increasing number of ms submitted.

The acceptance rate varies between countries (highest for the Nordic countries), but note that all manuscripts are evaluated by co-editors and reviewers outside the submitting country.

Subscriptions

On Dec 2015 (2014, 2013, 2012, 2011, 2010, 2009) we had 4 833 subscribers (4804, 4581, 4664, 4626, 4768, 4603).

4 605 were collective subscribers, 208 institutional (mainly libraries), and 20 personal (Tables 2-4).

Institutional (mainly libraries) subscriptions have, as expected, decreased: from 1703 in 1999 to 208 in 2015 (Table 3). The decrease is caused by our Open Access (although the decrease started already before we introduced OA).

The subscription cost for collective subscribers (orthopedic surgeons in the Nordic Orthopaedic Federation) has been unchanged since many years and is as low as 50 Euro since 1996, for others it is 783 Euro, low compared to most other journals.

Platinum Open Access

All full text Acta-articles published since start 1930 are free for everyone, easily accessible via a link at our web-site (www.actaorthop.org) to the electronic library of our publisher.

Acta articles from 2005 are also easily accessed via PubMed where abstracts are marked with an icon "Free Full Text" linked to our publisher. From 2009 all articles are deposited, and also available for free, in PubMed Central via a link from PubMed. Articles are immediately free as soon as proofs have been finished. Acta does not charge author fees. This type

of immediate OA, free of cost for both readers and authors, is called Platinum Open Access.

Our Open Access has led to a dramatic increase of the number of downloads of Acta articles: in 2015 the total number of full-text downloads from our publisher and Pubmed Central was 757 000 (2014; 576 000, 2013; 442 000), furthermore 280 000 only abstracts were downloaded. In comparison with other journals published by Informa these are very high numbers. In addition great many articles are downloaded directly from PubMed, however we have no statistics on that.

The top 12 countries (exclusive NOF countries) that download most full text content from Acta are: USA, UK, China, India, Australia, Germany, Japan, Canada and Switzerland.

End of printed Supplementums

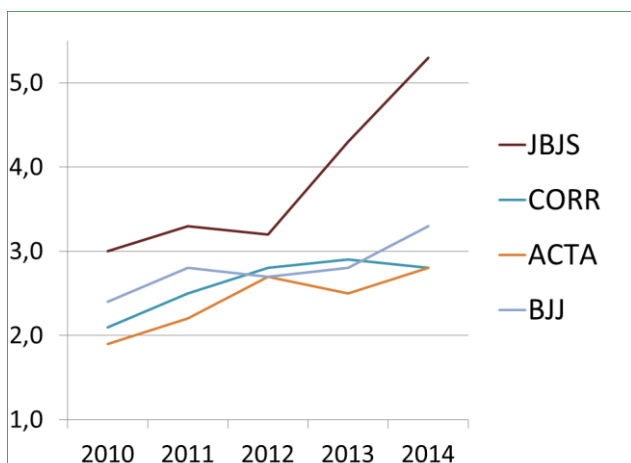
Acta has decided to stop printing paper supplements; most of them have been doctoral theses (based on a number of already published articles) which nowadays are easily available from the Universities. During recent years the print cost for a Supplementum has been paid for by the authors, the porto cost has been paid by Acta (around 15 000 Euro annually). A possibility for electronic only supplements remains; 2 will be published in 2016.

Creative commons; no copyright

Acta articles are distributed under the terms of the Creative Commons Attribution Non-commercial License, which permits any non-commercial distribution and reproduction: Acta has no copyright on articles.

Impact Factor

Acta's impact factor was 10 years ago 0.6, for 2014 (latest published data) it was 2.8, close to that of the 3 other large, general orthopedic journals. Among the 70 journals classified as "orthopaedics" Acta ranked 10 in 2014. JBJS was number 1 (IF 5.3), BJJ nr 5, and CORR nr 11. The next IF, for year 2015, will be published in June 2016.



Apps

Apps for iPhone and Android with free access to all (regularly updated) Acta articles and supplements since start 1930 were launched 2011 (first orthopedic journal). The App has now been downloaded by close to 15 000 users in 100+ countries who regularly check for and download articles. We get 100 new users per month.

Editors' meetings

The Editors have had 2 meetings, April in Skanör, Sweden and in October in Copenhagen. Some of the issues discussed are summarized:

The Skanör meeting started with a silent minute for Yrjö Konttinen (Memorial in April 2015 issue. Acta economy (how to decrease costs and increase incomes) was discussed. The main explanation for poor economy is the great loss of library subscriptions. Great costs are print (around 100 000 Euro/yr and porto, around 100 000 Euro/yr)

Thinner print paper (started 2016) will decrease porto costs which, of course, could be eliminated, together with print costs, by Acta going electronic only, a likely development. Incomes can be increased by an article processing charge (APC) as already used by many journals. A larger increase of ads (few last years) is unlikely.

Max number (3 300) of words in manuscript was decided. Jonas Ranstam lectured on poorly defined RCTs.

At the Copenhagen meeting Andy Beare (responsible for Manuscript Manager) summarized 10 years with Acta. The dramatic increase of so called predatory publishers (who soil the term Open Access) was discussed. Jonas Ranstam lectured on statistical Multivariate Models.

The Future

The Open Access movement will go on. Still few of the leading medical journals, including orthopedics, are Open Access. An increasing number of journals, owned by commercial publishers, offer authors to have their specific article laid free on the Net for a cost around 2000-3000 Euro.

Likely, Acta in the near future will be published electronically only and an article processing charge will be introduced.
